# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to www.1stkingtax.com, and 1st KING TAX AND INSURANCE and governs data collection and usage. # **Collection of your Personal Information**

In order to better provide you with products and services offered, 1st KING TAX may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
